

**CITY OF COSTA MESA
PROFESSIONAL SERVICES AGREEMENT
WITH
RCS INVESTIGATIONS AND CONSULTING, LLC**

This Amendment Number Three ("Amendment 3") is made and entered into this 17th day of August, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and RCS INVESTIGATIONS AND CONSULTING, LLC, a California limited liability company ("Consultant"), which hereby amends the professional services agreement dated May 19, 2022 ("Amendment 2") pursuant to the following terms and conditions.

RECITALS

- A. WHEREAS, City and Consultant entered into an initial professional services agreement on May 20, 2020, and Amendment 2 on May 19, 2022, for the Consultant to provide background investigation services on an as-needed basis, as more fully described herein; and
- B. WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for four (4) additional one (1) year periods; and
- C. WHEREAS, City and Consultant extended the terms of the initial Agreement in Amendment 2 from May 20, 2021, through May 19, 2023.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The term of the Agreement shall be extended through May 19, 2024.
- 2. All terms not defined herein shall have the same meaning and use as set forth in the initial Professional Service Agreement dated May 20, 2020.
- 3. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
- 4. This Amendment may be executed in one or more counterparts, each of which shall be deemed original. All counterparts shall be construed together and shall constitute one agreement.


