

**AMENDMENT NUMBER THREE TO
PROFESSIONAL SERVICES AGREEMENT
WITH
SUSAN SAXE-CLIFFORD, PH.D.**

This Amendment Number Three ("Amendment") is dated 31st day of May, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and SUSAN SAXE-CLIFFORD, PH.D., a professional corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on June 1, 2020, for Consultant to provide psychological evaluation services on an as-needed basis (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for four (4) additional one (1) year periods; and

WHEREAS, the City and Consultants extended the term through May 31, 2022, through Amendment Number One to the Agreement, dated May 31, 2021; and

WHEREAS, the City and Consultants extended the term through May 31, 2023, through Amendment Number Two to the Agreement, dated May 31, 2022; and

WHEREAS, the City and Consultant desire to extend the term for one (1) year, through May 31, 2024.

WHEREAS, the City and Consultant intend and desire that this Amendment be effective retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be effective retroactive to the Effective Date.
2. The term of the Agreement shall be extended through May 31, 2024.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


