

**AMENDMENT NUMBER FOUR TO
PROFESSIONAL SERVICES AGREEMENT WITH
LYONS SECURITY SERVICE, INC.**

This Amendment Number Four ("Amendment") is made and entered into this 20th day of October, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and LYONS SECURITY SERVICE, INC. a California contractor ("Contractor").

WHEREAS, City entered into an agreement with Contractor on July 1, 2019, for Contractor to provide unarmed security guard services (the "Agreement"); and

WHEREAS, City and Contractor entered into Amendment Number 1 to extend the term of the Agreement through June 21, 2021; and

WHEREAS, City and Contractor entered into Amendment Number 2 to extend the term of the Agreement through June 28, 2022; and

WHEREAS, City and Contractor entered into Amendment Number 3 to extend the term of the Agreement through June 21, 2021 and increase Contractors compensation; and

WHEREAS, City and Contractor now desire to increase Contractor's scope of work and compensation accordingly.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Recitals set forth above are true and correct and incorporated herein by this reference.
2. Section 1.1 of the Agreement is amended to increase Contractor's Scope of Work to add the provision of four additional un-armed security officers (one officer at each site) at Pomona, Whittier, Rea, and Wilson Elementary Schools. Security service at each site shall be from 3:30 pm to 8:30 pm Monday through Friday and 8:00 am to 8:00 pm Saturdays and Sundays as more specifically set forth in Exhibit "A."
3. Section 2.1 of the Agreement is amended to increase Contractor's maximum compensation commencing on the Effective Date of this Amendment to \$579,362.72
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
5. All other terms, conditions, and provisions of the Agreement

shall remain in full force and effect.

6. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


