### 3. NEW BUSINESS

a. Request for proposal for Animal Services Update

Ms. Torrejon presented the Animal Care Services Staff Report to the committee.

Ms. Cattouse updated the committee and informed the RFP is under review and expected to go to Council in March.

Ms. Torrejon provided an update on the ongoing RFP process. She informed the committee that shelter fees are currently pending the completion of the RFP as they need to be agreed upon by the provider and the City.

Chair Walls asked for shelter fees to be posted for the public when available on City website as well as on the Provider's website.

Lt. Selinske informed the Committee that fees cannot be posted until the RFP goes to Council and the fees are approved. A social media post will be created for those fees when they are available.

Committee Member Tanaka asked about Priceless Pet Rescues amendment contract. Asked about Newport Mesa Animal Hospital.

Ms. Torrejon informed Ms. Tanaka the City entered a temporary shelter services contract with Priceless Pets and they have an agreement with Newport Mesa Animal Hospital to assist them with some of their shelter medical services.

Committee member Poulos asked for clear explanation for what is needed to pick up a pet from the shelter.

### 4. MONTHLY REPORTS

a. Animal Care Services Staff Report

Ms. Torrejon presented the Animal Care Services Staff Report to the committee.

Ms. Torrejon updated the Committee on the final transfer of all remaining shelter animals from Newport Center Animal Hospital to Priceless Pet Rescue. She informed the committee it went smoothly.

Ms. Torrejon informed the committee on the upcoming animal services event, Spring Bark Bash scheduled for April 13, 2024 at TeWinkle Park.

Ms. Cattouse updated the committee on the onboarding of new Animal Control personnel and that Animal Control Services are hoping to be extended to 7-days a week.

Lt. Selinske updated the committee about the department working on filling ACO Cattouse's animal control spot and the ongoing recruitment to fill the other position for Animal Services.

Vice Chair Minjares asked about the 23 impounded cats in the December stats.

Ms. Cattouse updated the committee that there was a house with cats that were abandoned and taken to shelter.
