AMENDMENT NUMBER THREE TO PROFESSIONAL SERVICES AGREEMENT WITH RJM DESIGN GROUP, INC.

This Amendment Number Three ("Amendment") is dated December 28, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and RJM DESIGN GROUP, INC., a California corporation ("Consultant").

WHEREAS, City and Consultants entered into Amendment One on August 22, 2022, to extend the Agreement through February 28, 2023; and

WHEREAS, City and Consultant entered into Amendment Two on August 23, 2023, to extend the Agreement through December 31, 2023; and

WHEREAS, Section 4.1 of the Agreement provides for the term of the Agreement to be amended if agreed to in writing by the parties; and

WHEREAS, City and Consultant desire to extend the term through December 31, 2024.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The term of the Agreement shall be extended through December 31, 2024.
- 2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
- 3. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
- 4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
