

**AMENDMENT NUMBER ONE TO  
PROFESSIONAL SERVICES AGREEMENT  
WITH  
ADVANTAGE MAILING, LLC**

This Amendment Number One ("Amendment") is dated March 11, 2024, by and between the CITY OF COSTA MESA, a municipal corporation ("City") and ADVANTAGE MAILING, LLC, a Delaware limited liability company ("Consultant").

WHEREAS, City and Consultant entered into an agreement on March 21, 2023 for recreation magazine printing services (the "Agreement"); and

WHEREAS, the City originally contracted for services which excluded mail preparation and delivery services; and

WHEREAS, City and Consultant desire to increase each year's not-to-exceed amount by \$2,620.00 to cover the additional cost of the mail preparation and delivery services.

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Section 2.1 is revised to provide in full:

"Compensation. Consultant shall be paid in accordance with the fee schedule set forth in Exhibit "C," attached hereto and made a part of this Agreement (the "Fee Schedule"). Consultant's total compensation for Year One shall not exceed \$82,264. Consultant's total compensation for Year Two shall not exceed \$83,952. Consultant's total compensation for Year three shall not exceed \$85,632."

2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.


3. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.

4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
