

**AMENDMENT NUMBER THREE TO
PROFESSIONAL SERVICES AGREEMENT WITH
NANCY K. BOHL, INC. DBA THE COUNDELING TEAM INTERNATIONAL**

This Amendment Number Three ("Amendment") dated October 27, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and NANCY K. BOHL, INC., a California corporation DBA THE COUNSELING TEAM INTERNATIONAL ("Consultant").

WHEREAS, City and Consultant entered into an agreement on June 1, 2020 for Consultant to provide psychological evaluation services on an as-needed basis (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the terms of the Agreement for four (4) additional one (1) year periods; and

WHEREAS, City and Consultant extended the term through May 31, 2022, through Amendment Number One to the Agreement, dated May 31, 2021; and

WHEREAS, City and Consultant extended the term through May 31, 2023, through Amendment Number Two to the Agreement, dated May 31, 2022; and amended the Fee Schedule; and

WHEREAS, City and Consultant now desire to extend the term for one (1) additional year, through May 31, 2023; and

WHEREAS, City and Consultant desire to amend the Fee Schedule as set forth herein.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of the Agreement is extended through May 31, 2025.
2. The Fee Schedule set forth in Exhibit C to the Agreement shall be deleted in its entirety and replaced with the Amended Fee Schedule attached hereto as Exhibit "A." City will pay Consultant in accordance with the Amended Fee Schedule commencing on May 1, 2023.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
4. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
5. This Amendment may be executed in one or more

counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.




