AMENDMENT NUMBER ONE TO PROFESSIONAL SERVICES AGREEMENT WITH JFK TRANSPORTATION CO., INC.

This Amendment Number One ("Amendment") is dated June <u>1</u>, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and JFK Transportation Co., Inc.("Consultant").

WHEREAS, City and Consultant entered into an agreement on June 1, 2023 for Consultant to provide professional transportation services to transport program and event participants to destinations in various routes more specifically described in Exhibit "A" attached to the June 1, 2023 Agreement; and

WHEREAS, City and Consultant originally established an annual not-to-exceed amount of \$35,000; and

WHEREAS, City and Consultant desire to increase the annual not-to-exceed amount to \$50,000; and

WHEREAS, City and Consultant originally established a one year term, ending on May 30, 2024 with a provision to extend the agreement up to four additional one year periods upon mutual agreement of both parties; and

WHEREAS, City and Consultant agree to extend the agreement for one year, commencing on June 1, 2024 and ending on May 30, 2025.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The second sentence in section 2.1 is revised to state, "Contractor's total compensation shall not exceed \$50,000.00 annually."
- 2. Section 4.1 is restated as follows: "Term. This agreement shall commence on June 1, 2024 (the Effective Date of this Amendment Number One) and continue for a period of one year, ending on May 30, 2025, unless previously terminated as provided herein or as otherwise agreed to in writing by the parties. This Agreement may be extended by up to three additional one-year periods upon written agreement of both parties."
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
- 4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.

5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
