

**AMENDMENT NUMBER ONE TO
PROFESSIONAL SERVICES AGREEMENT
WITH
ARDURRA GROUP, INC.**

This Amendment Number One (“Amendment”) is dated June 30, 2024, (“Effective Date”), by and between the CITY OF COSTA MESA, a municipal corporation (“City”) and ARDURRA GROUP, INC., a Florida corporation (“Consultant”).

WHEREAS, City and Consultant entered into an agreement on January 26, 2024 for Consultant to provide Transportation and Engineering support services to the City’s Transportation Services Division (the “Agreement”) and

WHEREAS, Section 4.1 of the Agreement provides for a term of five months, ending on June 30, 2024, with the option to extend the Agreement for three additional one-year periods; and

WHEREAS, City and Consultant desire to extend the term of the Agreement for one (1) year, through June 30, 2025; and

WHEREAS, City and Consultant intend and desire that this Amendment Number One be retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This amendment shall be retroactive to the Effective Date.
2. The term of the Agreement shall be extended through June 30, 2025.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
