## AMENDMENT NUMBER FOUR TO PROFESSIONAL SERVICES AGREEMENT WITH BARR & CLARK, INC.

This Amendment Number Four ("Amendment") is dated July 1, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and BARR & CLARK, INC., a California corporation ("Contractor").

WHEREAS, City and Contractor entered into an agreement on March 1, 2021 for Contractor to provide lead-based paint testing services (the "Agreement") and

WHEREAS, Section 4.1 of the Agreement provides for a term of one year expiring on June 30, 2022, with the option to extend the Agreement for three additional one year periods; and

WHEREAS, City and Contractor exercised the first of three options to extend the term and revised the fee schedule through Amendment Number One, dated June 30, 2022; and

WHEREAS, City and Contractor increased Contractor's maximum compensation through Amendment Number Two, dated September 20, 2022; and

WHEREAS, City and Contractor exercised the second of three options to extend the term through Amendment Number Three, dated July 21, 2023; and

WHEREAS, City and Contractor now desire to exercise the third of three options to extend the term, with no increase in compensation.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The term of the Agreement shall be extended through June 30, 2025, with no increase in compensation.
- 2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
- 3. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
- 4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
