Re: Santa Ana Ave. bike lanes in front of Kaiser Elementary School

I am unable to attend this meeting because, like so many Kaiser and Woodland parents, I am just not available at 5pm on a school night–I'll be coaching my 9-year-old daughter's soccer team. And even if we were available, the many hundreds of people that use the Santa Ana bike lane are not only likely unaware of this meeting, but unaware that the improvement is something they need to fight to preserve. Every parent that I've talked to, along with the crossing guards, have agreed that this closure in the bike lane gap was an obvious needed improvement. Since school started a few weeks ago, the bike cage is so full that it's difficult for the last kids that arrive to find an open spot. It wasn't like this last year.

Over the last several decades, our neighborhood-like so many across the country-went from one where kids roamed on bikes and knew to come home "when the street lights come on" to one where kids can hardly cross the street without adult supervision. Kids can't get to each other anymore, they can't get to soccer practice, they can't get to school. The cars have gotten larger, faster, more distracting, and more insulated. We drivers have become more entitled and careless. As a result, kids' radii of freedom have shrunk to the edge of their driveways.

Popular psychologist Jonathan Haidt has been helping parents raise healthy kids in an increasingly changing environment, and offers concrete advice to reverse the worrying trends of anxiety, dependency, and loneliness: keep the kids off phones and social media and *give them more independence*, *play*, *and responsibility in the real world*. How can we do this if even our neighborhood streets are prohibitively dangerous? You have the power to enable parents to raise healthier kids.

And it's not only little kids that benefit from this improvement (though they should be given special consideration). Students of Ensign and Newport Harbor use the bike lane, along with everyone making their way on bikes to the businesses on E. 17th St., to the Peninsula, and even north to the Fairgrounds. While drivers on the Eastside are given convenient access in every direction through a variety of possible routes, this is the sole north/south route provided for those on bikes (where they don't have to share space with 30+ mph vehicle traffic).

Our city is on its way to having something resembling a complete bike-able network-something that, if/when finished, will still pale in comparison to the extent of the drive-able network. We cannot allow the little that we have-especially here-to be taken away so that parking can remain convenient for the privileged few.

With yet another tragic death of a cyclist just this week in nearby Huntington Beach (Daily Pilot, "Motorist arrested after cyclist killed in hit-and-run DUI in Huntington Beach", Oct. 1), now is the time to be taking MORE action to protect cyclists and our children biking to school, not less.

This is simply another incident that is a sobering reminder that we need to prioritize the safety of those who choose sustainable, healthy transportation options like biking. The recent improvements to Santa Ana Avenue are a step in the right direction, and I am writing to strongly urge the City to maintain these changes and even consider enhancing them further via a much needed physical barrier.

As a Costa Mesa resident and parent at both Kaiser and Woodland Elementary, I'm deeply concerned about cyclist safety, particularly in our residential areas. Over the summer, many of us voiced support for the installation of the bike lane on Santa Ana Avenue, and it's been wonderful to see how well it's been received by the community. More children (and parents!) are biking to school than ever before, and the feedback has been overwhelmingly positive. The onceempty bike rack at Kaiser is now nearly full every day, which is a testament to the success of this project.

However, apparently some anti-safety residents have voiced opposition and are actively working to reverse the project. I believe it is critical that we stand firm in support of this bike lane, and the many others needed, which has already made our streets safer and more accessible for cyclists of all ages. The changes, including the removal of curbside parking on the east side and the addition of a southbound bike lane, have created a safer biking environment for everyone.

In fact, in light of the recent tragedy, I believe we should go even further. The bike lane on Santa Ana Avenue needs a physical barrier to protect cyclists from vehicular traffic. As we've seen, bike lanes alone are not always enough to prevent accidents. A barrier would provide an additional layer of protection and make it clear that cyclist safety is a priority for Costa Mesa.

I urge you to preserve the improvements made to Santa Ana Avenue and to continue taking bold steps to protect cyclists across the city, enhancing the overall appeal and safety of the community. The benefits of these changes far outweigh the minor inconveniences of lost parking spaces. Supporting bike lanes is an investment in our community's safety, health, and future. We cannot afford to roll back these essential safety measures.

Thank you for your continued work on behalf of our community, and thank you for considering the safety of cyclists as a top priority.
