AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT WITH COMMUNITY CATALYST

This Amendment Number Two ("Amendment") is dated March 14, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and Community Catalyst, Inc., an S Corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on March 14, 2024 for Consultant to perform planning services (the "Agreement") and

WHEREAS, Section 2.1 of the Agreement provides for compensation at an amount not-to-exceed twenty fifty thousand dollars (\$25,000); and

WHEREAS, City and Consultant established a revised annual not-to-exceed amount from \$25,000 to \$50,000 through Amendment Number One, dated May 30, 2024; and

WHEREAS, the parties now desire Consultant to provide additional planning related services, which requires an increase in compensation.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The second sentence in section 2.1 of the Agreement is revised to state, "Consultant's total compensation shall not exceed one hundred thousand dollars (\$100,000)."
- 2. Exhibit "A" to this Amendment replaces the Exhibit "A" of the original Agreement.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
- 4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
- 5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
