

**AMENDMENT NUMBER THREE TO  
MAINTENANCE SERVICE AGREEMENT  
WITH  
QUINN COMPANY**

This Amendment Number Three ("Amendment") is dated August 30, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and QUINN COMPANY, a California corporation ("Contractor").

WHEREAS, City and Contractor entered into an agreement on December 17, 2021 for Contractor to provide periodic preventative maintenance on City equipment; and

WHEREAS, on December 17, 2022, the City and Consultant extended the Agreement for one (1) year (Amendment One) through December 16, 2023; and

WHEREAS, on May 9, 2024, the City and Consultant extended the Agreement through December 16, 2024 (Amendment Two); and

WHEREAS, Section 2.1 of the Agreement provides that Contractor's total compensation shall not exceed \$13,250.00 annually; and

WHEREAS, Section 2.2 of the Agreement allows Contractor to increase the amount of compensation if the City requests additional services under the Agreement; and

WHEREAS, City and Contractor now desire to approve an increase in compensation not to exceed \$25,000.00, which amounts to an annual increase of \$11,750.00; and

WHEREAS, City and Contractor intend and desire that this Amendment Number Three be retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be retroactive to the Effective Date.
2. Section 2.1 of the Agreement is amended to increase compensation to an amount not exceeding \$25,000 annually to account for additional services performed under this Agreement.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.

5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
